B. FEED AND FACILITIES

STABLE agrees to provide the following, in addition to normal and reasonable care and handling to maintain the horse(s).

Board Type: SELF BOARD FULL BOARD PASTURE BOARD

SELF BOARD: Owner is responsible for all feeding, care and maintenance of their horse and keeping pen clean. Stable will repair waterer and regular wear and tear on shelter and fences. If the Owner's horse damages the property then the Owner is responsible to repair damage. i.e. replace chewed rails or boards.

FULL BOARD: Stable is responsible for feeding and supplying hay only. Owner is still responsible to keep pen clean and care of their horse.

Stall and Paddock Cleaning may be arranged for an additional charge. If you do not clean your pen/stall on a regular basis, you will be given notice and if you still do not get it done, the stable will do it for you and you will be charged accordingly.

PASTURE BOARD: Stable is responsible for feeding and supplying hay only. Owner is responsible to check on and care for their horse regularly.

SUB-LEASING: Owner may, at the discretion of the Stable, sub-lease a pen to another person/horse for a maximum of 5 months, at which time, the paddock will be offered to the next person in line waiting for a pen.

*2 weeks' notice must be given before vacating or a penalty amount will be charged. Stall or paddock must be left clean or cleaning charges will apply.

Boarders will be charged for any medications, drugs or supplements required to be administered by the STABLE. Boarders will be charged a \$20.00 fee for handling of a horse by the STABLE during farrier or vet visits. Handling fees will be added to the monthly board rate. Boarder is responsible to pay farrier, veterinarian or other professional service fees directly.

C. VACCINATIONS

Recommend a minimum of an annual 4-Way vaccination.

D. RISK OF LOSS

During the time that horse(s) is/are in the custody of STABLE, STABLE shall not be liable for any SICKNESS, DISEASE, THEFT; DEATH OR INJURY WHICH MAY BE SUFFERED BY THE HORSE. This includes, but is not limited to, any personal injury or disability the horse may receive while on the STABLE premises. OWNER acknowledges and agrees that STABLE does not carry any insurance on any horse(s) not owned by STABLE, including but not limited to, such insurance for boarding or any other purposes for which the horse(s) is/are covered under any public liability, accidental injury, theft or equine mortality insurance. THAT ALL RISKS RELATING TO BOARDING THE HORSE(S), OR ANY OTHER REASON FOR WHICH THE HORSE(S) IS IN THE POSSESSION OF STABLE SHALL BE BORNED BY OWNER.

E. HOLD HARMLESS

OWNER agrees to hold STABLE harmless from any and all claims resulting from any damage or injury caused by said horse(s), OWNER, or OWNER'S guest and invitees, or in any way arising out of the STABLE'S duties under this Agreement, including but not limited to, legal fees and expenses incurred by STABLE in defense of such claims.

F. LIABILITY INSURANCE

We strongly recommend purchasing Horse Council B.C. for your liability protection.
